RESOLUTION NO. 2003-4

A RESOLUTION OF BOROUGH OF EAST PROSPECT, YORK COUNTY, PENNSYLVANIA INDICATING ITS INTENTION TO COMPLY WITH AND ENFORCE THE PROVISIONS OF THE PENNSYLVANIA UNIFORM CONSTRUCTION CODE, ACT 45 OF 1999, IN JOINT MUNICIPAL COOPERATION WITH HELLAM TOWNSHIP, HALLAM BOROUGH AND OTHER NEARBY MUNICIPALITIES.

WHEREAS, the Commonwealth of Pennsylvania enacted Act 45 of 1999, the Pennsylvania Uniform Construction Code ("UCC");

WHEREAS, the UCC establishes a statewide building code and provides mechanisms for the enforcement thereof,

WHEREAS, the UCC allows municipalities to work cooperatively for such enforcement purposes;

WHEREAS, East Prospect Borough, Hellam Township and Hallam Borough have agreed to commence efforts to establish a joint enforcement procedure under the UCC;

WHEREAS, East Prospect Borough, Hellam Township and Hallam Borough intend to solicit the cooperation of nearby municipalities in this effort;

WHEREAS, East Prospect Borough, Hellam Township and Hallam Borough desire, by and through this Resolution, to approve of the sharing of resources and services under the UCC.

WHEREAS, East Prospect Borough, Hellam Township and Hallam Borough desires to authorize the application of East Prospect Borough, Hellam Township and Hallam Borough, and other municipalities yet to be determined in a joint municipal effort to obtain any and all support that may be available from the Commonwealth of Pennsylvania for instrumentalities thereof, including, but not limited to grant monies.

NOW THEREFORE, BE IT SO RESOLVED BY THE BOROUGH COUNCIL OF EAST PROSEPCT BOROUGH, as follows:

<u>Section 1</u>. East Prospect Borough is resolved that it is authorized to investigate and to implement procedures to enforce the provisions of the UCC with Hellam Township, Hallam Borough and other municipalities yet to be determined.

- <u>Section 2</u>. East Prospect Borough anticipates that such investigation and implementation will ultimately be memorialized in an intergovernmental cooperation agreement.
- <u>Section 3</u>. East Prospect Borough may participate with Hellam Township, Hallam Borough and other municipalities yet to be determined in the joint application for grant monies and other assistance available to municipalities and municipalities cooperating jointly within the Commonwealth of Pennsylvania.
- <u>Section 4</u>. East Prospect Borough, and its duly authorized representatives and employees, may take any and all action necessary to further these purposes, provided that final approval of any intergovernmental cooperation agreement to be returned to the Borough Council of East Prospect Borough.
